The Board of Sheridan County Commissioners met at 9:00 a.m. Commissioners present were Howard Erdmann, Eldon Ehrman, and Michael Axt.

Chairman Erdmann called the meeting to order. The minutes of previous meeting as sent in the mail was approved by Commissioner Axt, seconded by Commissioner Ehrman. Upon roll call vote – Axt – yes, Ehrman – yes, Erdmann – yes Motion carried.

The time being 10:00 a.m. the hearing on the application for abatement of 2010 taxes filed by Troy Stein for grain bins located on Sublot 2 of Outlot A – Less Sublot A (City Ditch) in McClusky City was held. Axt reviewed the application with the true and full amounts currently set at \$292,330. Stein was present and requested the true and full value be lowered down to \$137,000 as per appraisal he presented. McClusky City Assessor, Sherril Houser, was absent. Cynthia Wahl, Tax Director, re-calculated the measurements and age of the structures utilizing the Marshal and Swift assessing guidelines and arrived at \$155,700 for a true and full value.

After serious consideration, it was moved by Commissioner Axt to approve the \$155,700 true and full value that was presented by the Sheridan County Tax Director's office, seconded by Commissioner Ehrman. Upon roll call vote - Axt - yes, Ehrman - yes, Erdmann - yes Motion carried. Wahl reported on the Offroads Software program is close to being completed with just the irregular parcels to be posted into the current tax program to implement the detail soils data for the 2012 County equalization meeting as requested by the 2009 legislature.

The application for abatement of 2010 taxes filed by Myron and Kathleen Mindt on the E2E2, N2NW4, SW4NW4, NW4SW4, SE4NW4, NE4 SW4, and S2SW4 10-145-74 was reviewed. It was moved by Commissioner Ehrman to reject the application due to the property owners were not eligible for inundated acres at this time, seconded by Commissioner Axt. Upon roll call vote – Ehrman – yes, Axt –yes, Erdmann – yes. Motion carried.

The time being 11:00 a.m. the County Commission Meeting recessed for the County Park Board meeting. The County Commissioner meeting reconvened at 11:30 a.m.

Wayne Houston and Cynthia Wahl, McClusky Rural Ambulance EMT volunteers, met with the board to review the McClusky Rural Ambulance District boundaries and the protocol that the ambulance follows as instructed by the ND Dept of Emergency Services.

The time being 1:00 p.m. Greg O'Shea, Butler Machinery representative, met with the board to present the new amortization charts of the payment plan for lease purchase of a 2011 Caterpillar motorgrader. It was moved by Commissioner Axt to amend the December 20th motion from purchasing the 2011 Caterpillar Motorgrader from a 5 year to a 7 year lease plan at 3.4% interest with Butler Machinery with monthly payments for the first year starting in April to be at \$2,700.00 and 6 annual payments at \$27,392.37 with a balloon payment of \$111,161.10 for a total of \$262,905.00 in order to lower the annual payments from what the previous lease would have been, seconded by Commissioner Ehrman. Upon roll call vote – Axt – yes, Ehrman – yes, Erdmann - yes Motion carried. Alvin Gross, road foreman, met with the board to request if the wings should be taken off the motorgraders yet. The board suggested waiting two weeks yet. Rosenfield Twp requested to roll their twp shoulder roads up to make a crown in the road. It was moved by Commissioner Axt that if a twp wants the County to roll their twp shoulders up the twp will be charged extra at \$125.00 per hr., seconded by Commissioner Ehrman. Upon roll call - Axt - yes, Ehrman - yes, Erdmann - yes, Motion carried. It was moved by Commissioner Ehrman to raise the road work rates to 125.00 per hour as filed in the Auditor's office, seconded by Commissioner Axt. Upon roll call vote - Ehrman - yes, Axt - yes, Erdmann - yes Motion carried. It was moved by Commissioner Ehrman to authorize the County Auditor to sign the official Butler Machinery contract for lease purchasing the 2011 Caterpillar Motorgrader upon receiving it, seconded by Commissioner Axt. Upon roll call vote - Ehrman - yes, Axt - yes, Erdmann – yes Motion carried. Gross was instructed to investigate in estimates on a new or different mower for mowing the County and twp road right of ways.

The time being 2:00 p.m. the County Commission meeting recessed for the County Planning meeting. The County Commission meeting recessed at 2:30 p.m.

It was moved by Commissioner Ehrman to approve the Variance Permit and Building permit as approved also by the County Planning Commission for NDDOT to allow constructing a 40'x 80' three sided building for salt and sand storage that will be within 200 ft of the highway right of way off of Highway 200 in Part of the NW4 Section 11-146-77 upon receiving the Variance Permit and building permit fees of \$250.00, seconded by Commissioner Erdmann. Upon roll call vote – Axt –yes, Ehrman – yes, Erdmann – yes Motion carried.

Sheriff, Trent Naser, met with the board to report he is still interviewing for replacing his 2^{nd} deputy sheriff position. It was moved by Commissioner Axt to increase the extra licensed police officer per hr rate to \$14.00 per hr effective immediately, seconded by Commissioner Ehrman. Upon roll call vote - Axt - yes, Ehrman – yes, Erdman – yes, Motion carried.

It was moved by Commissioner Axt to conduct a silent auction on County surplus property like office equipment, etc. with a closing date of Friday, April 29th at 12:00 p.m., seconded by Commissioner Ehrman. Upon roll call vote – Axt – yes, Ehrman – yes, Erdmann – yes Motion carried.

Emily Kline, County Agent, met with the board to present quarterly November- February County Agent narrative. Kline reported a new 4-H club has started up and was involved in livestock judging over the winter months. SCIPY has decided to end the after school program and start a new mentoring program. Agricultural programs have consisted of Crop and Cow day in Carrington, the Sheridan Improvement Assoc. annual meeting was held in conjunction with the Sheridan County Conservation District Achievement Awards night and the Ag Forum that was held in McClusky Feb 3rd. Kline has been answering a lot of producer phone calls from pasture rent rates to a wide array of ag related issues including conducting pesticide training. Kline has attended many training and in-services with NDSU ag and crop related issues in the last quarter. Kline entered into an Extreme Makeover County Extension Edition through NDSU and was a runner up who received a framed decorative picture for the County Extension office. The Spring Fling will be held April 20th at the McClusky City Hall.

It was moved by Commissioner Ehrman to approve the Special Use Permit (11-LM-60-0931) from the Bureau of Reclamation to extract up to 30,000 cu yds of gravel from the Schmidt gravel pit located in the Lonetree Wildlife Management Area at the SW4NE4 Section 30-149-74 for a 10 year term in the amount of \$2,000.00, seconded by Commissioner Axt. Upon roll call vote – Ehrman – yes, Axt – yes, Erdmann – yes Motion carried. Special conditions included in the permit was that the gravel must be used by County and Townships in Sheridan County, the gravel cannot be sold or given to a non-governmental entity.

It was moved by Commissioner Axt to approve purchase of a new HP computer for the County Recorders office in the amount \$1,218.12 from NDACo Resources Group, seconded by Commissioner Ehrman. Upon roll call vote – Axt –yes, Ehrman – yes, Erdmann – yes Motion carried.

SHERIDAN COUNTY, NORTH DAKOTA FLOOD DISASTER DECLARATION APRIL 15, 2011

WHEREAS, Sheridan County, North Dakota has received above normal snowfall for the winter season; and

WHEREAS, spring flooding has already proven significant due to spring thaw; and

WHEREAS, the impact of the thaw and runoff threatens the health, well-being and public safety of the citizens in Sheridan county including the cities of Goodrich, Martin, and McClusky; and

WHEREAS, the expense and time of cleanup, repair and replacement is in excess of available county and private resources and budgeted funds;

NOW THEREFORE, BE IT RESOLVED, that the Board of Sheridan County Commissioners declares a flood disaster exists in Sheridan County, North Dakota, and orders the activation and utilization of the county Emergency Operations Plan, its procedures, attachments and appendices to monitor the situation, alleviate hardship and initiate appropriate relief actions and mitigation measures by departments and agencies of local government to limit the hardships and impact of this emergency upon the citizens of Sheridan County.
