It was moved by Commissioner Ehrman to change the Weed Board terms of their effective starting dates to November 1st rather than July 1st, as the remaining terms of the Weed Control Board members are up, due to the State Weed Control Convention is held in January every year so when any new Weed Board member would be appointed to the Board they would receive training before the weed control season starts , seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Jorgensen – yes Motion carried.

It was moved by Commissioner Ehrman to approve the annual 2006 Pioneer Historical Society financial statement seconded by Commissioner Erdmann. Upon roll call vote – Ehrman –yes, Erdmann – yes, Jorgensen – yes Motion carried.

The application for abatement of the 2007 assessment values for Homestead Credit on Lots 16,17,18 Blk. 12, Original, McClusky City was reviewed and the abatement hearing was scheduled for September 4, 2007 at 10:00 a.m.

It was moved by Commissioner Erdmann to approve the building permit issued to Doug Houser for constructing a 60'x 80' cold storage building in Block 4, Pickardville or also known as part of the NW4 section 14-146-78, seconded by Commissioner Ehrman. Upon roll call vote – Ehrman – yes, Erdmann – yes, Jorgensen – yes Motion carried.

It was moved by Commissioner Ehrman to approve the Beer and Liquor licenses to Gary Berg & Andrea Kluck for only the July 21st event held at the 4-H building, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Jorgensen – yes Motion carried.

The time being 11:00 a.m. the County Commission meeting recessed for the County Park Board meeting. The County Commission meeting reconvened at 1:00 p.m.

Wayne Houston, Emergency Manager, met with the board to present a 9-1-1 street map showing the next phase of 911 signs to be installed off of the secondary roads in Sheridan County. It was moved by Commissioner Ehrman to approve the next phase of 911 signs to be ordered, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Jorgensen – yes Motion carried. Houston reported that homeland security monies were decreased for this year for our State, however; there is a one time communications grant coming up for our community communication projects. Houston also reported on testing the new sirens in McClusky and Denhoff.

Steve Reiser, Director of Dakota Central Social Services, met with the board to present the 2008 budget for Dakota Central Social Services that Sheridan County is a part of. It was moved by Commissioner Ehrman to approve the 2008 Dakota Central Social Services budget in the total amount of \$77,145.00, a reduction of \$53,355.00 from last year's budget, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Jorgensen – yes Motion carried. The County Commissioners requested Reiser to issue the County discount prescription cards from the Social Service office when the cards arrive.

Crystal Schaunaman, County Agent, met with the board to review the County Agent budget and inquired if the Farmers Union should pay rent for their day camp she conducted. The County Commission stated this will be tabled until the next park board meeting.

Trent Naser, Sheriff, met with the board to report that there is extra furniture and equipment in the Sheriff's storage shed that should be sold. Naser will report to the Auditor's office a list of surplus property to be advertised for sale. Naser reviewed his department budget and discussed hiring for a part time Sheriff's Deputy. Ideas were discussed with sharing a Deputy Sheriff with McHenry County. Naser will contact the McHenry County Sheriff to investigate this further or set up a meeting with the Commissioners from each County.

Joyce H. Dockter, County Recorder, met with the board to report that their Dell computer crashed after the electricity went out. The Commissioners approved to purchase a HP computer less a monitor with Office 2007software installed on it in the amount of \$779.22 from NDACo.

Alvin Gross, Road Foreman, met with the board to discuss road graveling and weed mowing issues.

At this time the 2008 County budget requests were reviewed. The County Commissioners meeting recessed until August 15^{th} at 9:00 a.m.

Licensing with the POST Board will need to be investigated further in order to be able to share deputy license between two counties or not.

The McHenry County Commission members will meet with the rest of their board and discuss these ideas further. In the meantime, Sheridan County will put together a proposal to be sent to the McHenry County Commission for consideration.
