It was moved by Commissioner Jorgensen to approve purchasing a laptop computer, multi-media projector, and DVD-VCR combo unit from Office Depot for less than \$2,000.00 out of the Homeland Security Grant monies that are available, seconded by Commissioner Ehrman. Upon roll call vote – Jorgensen – yes, Ehrman – yes All voting "yes" the motion carried. Houston also requested to purchase a desktop computer for his office that is budgeted for in his office for this year. It was moved by Commissioner Jorgensen to approve to purchase a desktop Hewlett Packard computer from the ND Assoc. of Counties State Contract, seconded by Commissioner Ehrman. Crystal Schaunaman, County Agent, met with the board to report on Extension activities throughout the month. The 4-H rodeo was held on July 9th during the McClusky Centennial and the turnout was good. 4-H Achievement days were held on July 15th and 16th with low public attendance possibly due to the hot weather, however; the 4-H raffle was a hit with many donated items to choose from. She assisted with the sheep show at the State Fair and some local 4-Hers showed sheep there also. Some question topics this last month have been on anthrax, canola disease, effect of scab on wheat and barley, ATV safety course trainings, bacterial infection on garden produce, kabatina and leaf spot on trees, and identifying and recommending solutions for several people on ground ivy, a particularly hard-to-kill lawn weed. She also attended a No-Till In-Service held in Mandan. An interview was held for the Family Nutrition Program position in July and was offered to the candidate with a possible September start date. EDC is working on educating the public to continue the 1% sales tax that will be voted on a Special City Election in October or November of this year. SCIPY will host their annual canoe trip August 8th & 9th at Hoffer's Lake Recreation Area.

The time being 11:00 a.m. the County Park Board meeting was held. The County Commission reconvened at 1:00 p.m.

At this time LaRae Dockter and Sherry Korus, representatives from KED Inc., aka as the Union Grill & Bar, McClusky met with the board to request a special event permit to sell alcoholic beverages in the 4-H building at the Hoffer Lake Recreation Area on September 3rd for Arlington Helm's "50th" Wedding Anniversary event and to voice concern of the County rules and regulations to sell alcoholic beverages that states no additional permit shall be issued until 30 days have passed from the initial special event permit due to there may be another event that they could serve at within the 30 day period. It was moved by Commissioner Jorgensen to approve the special event permit to KED, Inc. for the Helm Anniversary event on September 3, 2005 and to omit from the Sheridan County Rules and Regulations to sell alcoholic beverages the 30 day limit on the special event permit as filed in the County Auditor's Office, seconded by Commissioner Ehrman.
