The time being 2:00 p.m. the abatement hearing for Allan Tinker for her property in Harris Twp. was held. Allan Tinker was present. Others present were Cynthia Wahl, Tax Director, James Haux, Assessor in Harris Twp., Sherril Houser, City and District Assessor, Sarah Hewsen, State Tax Commissioner's Office The history of values were reviewed back to year 2001 by the Tax Director and with the exception of three parcels the values were increased and decreased percentages across the board up to the present value as instructed by the State Tax Commissioner Office ag land values. Cropland and non cropland issues were discussed. Brian Tinker arrived at 2.20 p.m. Brian Tinker and Cynthia Wahl will review calculations on the valuation spreadsheet. The hearing was tabled until 3:00 p.m. January 4, 2005.

Crystal Schaunaman, County Agent, met with the board to report on the Extension activities for the last month. The 4-H Awards night was held Nov. 21 in Goodrich with low attendance. 4-H issues were discussed briefly. Schaunaman attended a few conferences in the last month at Bismarck and Carrington to help answer a few questions that producers have on a variety of topics Schaunaman spoke at the Sheridan County

Farmer's Union annual convention held at McClusky on the impact of declining farmers that affect a small community. A reorganization meeting/supper of the Sheridan Association was held on November 29 in McClusky with 30 farmers attending. Sheridan County in Partnership with Youth (SCIPY) held a recruitment dinner on November 16th to come up with new ideas and more volunteers.

Roger Trautmann, Equipment Operator, and Alvin Gross, Road Foreman, met with the board to report that weed mowing has been completed and bales need to be removed off the road right of way. Contacts will be made to landowners to remove bales or they will be burnt. Trautmann was inquiring about shortening his route. The northwest corner of his route will be transferred to Cecil Schuh since it is closer to Schuh unless help is needed later on.

Jorgensen reported she received estimates on carpet and installation of carpet in the amount of \$1,100.00 for the front of the Courtroom to take care of the echoing effect. A court facilities improvement grant through the ND Supreme Court is available until December 31, 2004. The Auditor was instructed to complete the grant for the carpet to be installed in the courtroom with the County's share being \$275.00.
