#### COUNTY COMMISSIONERS MEETING JUNE 5, 2001

The Board of County Commissioners met at 9:00 A.M. Commissioners present were Gordon O. Felchle, Eldon Ehrman, and Shirley J. Jorgensen.

Chairman Felchle called the meeting to order. The minutes of the previous meetings was read and approved.

The time being 10:00 A.M. the application for abatement of settlement of 1998 taxes filed by Todd Lasher for on all of Section 25-146-77 was reconsidered as scheduled. An assessment analysis was presented by Todd and Vickie Lasher. Cynthia D. Wahl, Tax Director, stated the cropland and noncropland acres are gradually being reassessed for each township in order to equalize the County. It was moved by Commissioner Jorgensen to approve the McClusky Township recommended True & Full value assessment from \$100,926 to \$74,548 due to use of land is used for grazing instead of cropland, seconded by Commissioner Ehrman. Upon Roll Call vote --Jorgensen – Yes, Ehrman – Yes, Felchle – Yes All voting "Aye" the motion carried.

It was moved by Commissioner Ehrman to authorize the County Auditor to pay out the remaining year 2000 15% FEMA amounts to the organized townships when received from the State Emergency Division, seconded by Commissioner Jorgensen. All voting "Aye" the motion carried.

The time being 11:00 A.M. the County Park Board meeting was held. The County Commission meeting reconvened at 1:00 P.M.

At this time the pre-job construction conference was held for the 4.5 miles north of Goodrich and .56 of a mile south of McClusky. Present were Thomas Sprenger, NDDOT, Bob Allen, NDDOT, Curt

Grudniewski, Border States Paving Inc., Ed Baker, Road Foreman, Holly Beck, Wold Engineering, Mack Susag, Susag Sand & Gravel, Punch Becker and Herb Bargmann, Wold Engineering. Start of Construction will be scheduled for 2<sup>nd</sup> week of July. Completion deadline is October 20, 2001. Subcontractors are Pioneer Sand, Susag Sand, Border State Paving, Inc., 3-D Specialties, J & J Coating, Mann Trucking. The City of McClusky and Dave Martwick will be doing some patchwork paving with Border States Paving.

Mike Goos, US Fish & Wildlife, met with the board to present the wetlands payment in the amount of \$8,695.00 to be distributed to townships and school districts. Goos reported the wetlands payment has decreased some from last year.

James Haux, landowner, met with the board to discuss that the township road to his residence is near being under water and requested that FEMA consider building road up going along the east section lines. Further investigation and contacts with FEMA will be done.

Wayne Houston, Emergency Manager, announced the President of USA declared North Dakota a State of Disaster for 2001. A FEMA briefing meeting will be held at the Harvey High School at 2:30 p.m. The County Commissioners and Mr. Houston will be attending.

The time being 2:00 P.M. the County Equalization Meeting and at 2:30 P.M. the Redistricting Board Meeting was held. The County Commission meeting reconvened at 3:00 P.M.

Bennie Martin, Strassburg Twp. Officer, and Ed Baker, Road Foreman, met with the board to report that Dean Kolschefski, Kief, has a stack of bales on two approaches along the Farm to Market road right of way. The States Attorney will be contacted to send a letter of removal of bales.

Ed Baker, Road Foreman, met with the board to discuss road sites that are damaged and culverts that need to be installed. Commissioners encouraged Mr. Baker to start mulching road sides.

At this time County Employees were called to meet with the County Commission to organize a Parade Float committee for the Centennial Goodrich Parade and McClusky Mid-Summer Fest Parade. Float Committee consists of Denise Melom, Janice Erdmann, Eldon Ehrman, Larry Gessner, and Matthew Johansen. Wayne Houston is in charge of Banners.

Kent Alderin, County Agent, met with the board to report on monthly events, SCIPY picnic was held, Home Economist position is being advertised, and the Grazing Conference was held. Alderin also reported that the new Weed Control Officers hired were Craig Zimprich and Patrick Fylling and that they purchased a new sprayer tank for the 4-wheeler that was broke.

It was moved by Commissioner Ehrman to approve Joyce H. Dockter to attend the Register of Deeds Convention at Devils Lake June 7 & 8, Shirley A. Murray to attend the County Auditors Convention in Bismarck, June 14 & 15 at Bismarck, and Janice Erdmann to attend the County Treasurers Convention June 13,14,&15 at Bottineau, seconded by Commissioner Jorgensen. All voting "Aye" the motion carried.

Larry Gessner, Sheriff, met with the board to report that his office entered into a lease purchase for a Kyocera copy machine for 3 years at \$61.00 per mth with Fireside Office Products. Commissioners recommended prior Commission approval before any major purchases are made in the future.

It was moved by Commissioner Jorgensen to re-appoint Arthur Waltz to the Sheridan County Housing Authority Board for another 5 year term, seconded by Commissioner Ehrman. All voting "Aye" the motion carried.

The County Auditor reported that the following building permits were issued in May for in rural Sheridan County:

## SHERIDAN COUNTY EQUALIZATION MEETING June 5, 2001

The Sheridan County Board of Equalization met at 2:00 as set. Members present were Gordon O. Felchle, Eldon Ehrman and Shirley J. Jorgensen. Also present were various City and Township Officials and Assessors and the Director of Tax Equalization, Cynthia D. Wahl.

The meeting was called to order by Chairman Felchle.

The first order of business was the equalization of residential property. The assessments were as returned by the assessors and local boards were reported by the County Auditor and discussed. All present were given the opportunity to be heard. Cynthia Wahl, Tax Director recommended to the board to decrease the residential Structure values by 2% to stay within the 5% tolerance allowed by the State and that all cities within the County conduct a reassessment on all residential structures in their cities in order be equalized. It was moved by Commissioner Jorgensen to approve the 2% decrease on Residential Structures across the County in order to stay within the tolerance allowed by State and ordered the Cities within Sheridan County to conduct a reassessment on their residential structures for next years assessment period, seconded by Commissioner Ehrman. Upon Roll Call Vote – Jorgensen – Yes, Ehrman – Yes, Felchle – Yes All voting "Aye" the motion carried.

The second order of business was the equalization of commercial property. The assessments as returned by the assessors and local boards was reported by the County Auditor and discussed. All present were given the opportunity to be heard. Cynthia Wahl, Tax Director reported that the total Commercial values were within the 5% tolerance allowed by State. It was moved by Commissioner Jorgensen that no changes be made to the commercial property, seconded by Commissioner Ehrman. Upon Roll Call Vote Jorgensen – Yes, Erhman –Yes, Felchle – Yes All voting "Aye" the motion carried.

The third order of business was the equalization of agriculture property. The assessments as returned by the assessors and local boards were reported by the County Auditor and was discussed. The Tax Director reported there was inundated acres reported in Prophets and Mountain City Twps that decreased the values for those townships, and the ag values were increased by 4% across the County as requested by State and that Harris twp. reassessment of the whole township is still being conducted according to the Soil Survey and will hope to be completed by February 1, 2002. All present were given the opportunity to be heard. No other changes were reported. It was moved by Commissioner Ehrman that no changes be made, seconded by Commissioner Jorgensen. Upon roll call vote. Ehrman – Yes, Jorgensen – Yes, Felchle – Yes All voting "Aye" the motion carried.

The Senior Citizens Homestead tax credit and disabled tax credit applications were reviewed. The County Auditor reported there were 16 applications in all and 1 Blind and disabled application. It was moved by Commissioner Ehrman that the applications be approved as approved by assessors and City Boards, seconded by Commissioner Jorgensen. Upon roll Call vote Felchle –Yes, Jorgensen – Yes, Ehrman – Yes All voting "Aye" the motion carried.

The County Auditor presented the State Land and ND Game & Fish land subject assessment in lieu of ad valorem tax for a total True & Full Value of \$5,286,802 with the 4% ag increase added on to last year's values. It was moved by Commissioner Ehrman to approve that the State Land and ND Game & Fish land subject to assessment in lieu of ad valorem tax be assessed as per abstract of valuations on file in the Auditor's Office, seconded by Commissioner Bauer. All voting "Aye" the motion carried.

Other business discussed was the issues of Weed Mowing. Townships can assess weed mowing charges against the land owner by sending in the assessed charges to the County Auditor's office by November 1<sup>st</sup> with the land description to be charged.

There being no further business the meeting adjourned.

FEMA representatives will be meeting with organized twp supervisors for their reported damages. A hydrologist must be contacted before installing any culverts

The almost inundated township road to the James Haux residence was discussed. Possibly constructing a road 3 miles straight East of James Haux on section line trail to the north McClusky secondary road was considered. Estimates of construction will be requested from Holen Const. Estimate is to be faxed to the State Emergency Management office.
