It was moved by Commissioner Ehrman to elect Michael Axt as Vice-Chairman for the ensuing year, seconded by Commissioner Erdmann. Upon roll call vote ó Ehrman ó yes, Erdmann ó yes, Axt ó yes Motion carried.

It was moved by Commissioner Axt to cancel LeRoy Beckerøs weed mowing bill and post the weed mowing bill to the correct description for US Fish & Wildlife on the NW4 32-150-75 and also

cancel the weed mowing bills from Ronnie Krueger and Viola Leroy on NE4 Section 10 and W2NW4 Section 11 both in 147-77, seconded by Commissioner Erdmann. Upon roll call vote ó Axt ó yes, Erdmann ó yes, Ehrman ó yes.

The board met with Stein to talk about a complaint from Timothy Strobel. The matter was discussed and the claims were unsubstantiated.

Sarah Crimmins, McClusky, newly hired County Extension Agent met with the board to introduce herself.

Cynthia D. Wahl, Tax Director, with the board to report that the soils committee is meeting this afternoon to consider some soil types to be adjusted to lower PI¢ (Product Index) due to poor drainage in the soils and would not be productive, therefore have less valuation assessed for tax purposes.

John Halcrow called by speakerphone to the board to disagree with receiving a weed mowing bill for weed mowing that he done already on Section 26 SE4-145-77. No action was taken.

Arlin and Annie Fylling met with the board to discuss the hiring process in a shared position under two county elected officials of where would the accountability be in checks and balances. States Attorney, Ladd Erickson, was contacted by speakerphone to inquire about sharing a secretary between the Sheriff and Clerk of Court office. Erickson will contact Judge Hagerty if there are any conflicts for a secretary shared between those offices.

The County Auditor reported that the Union applied for a Sunday alcohol permit for February 3rd (Super bowl Sunday) that was issued to them.

The Auditor reported that the 2012 General Election cost was \$7.32 per vote. The cost per vote decreased from the 2010 General election at \$9.65 per vote due to increased voter turnout.

The Road Foreman met with the board to discuss hauling rocks if feasible as the weather allows on the north farm to market road from Goodrich.

Janice Erdmann, County Treasurer, met with the board to review the pledge of assets. It was moved by Commissioner Axt to approve the Pledge of Assets as provided by the County Treasurer and filed in the Auditor¢s office, seconded by Commissioner Ehrman. Upon roll call vote ó Axt ó yes, Ehrman ó yes, Erdmann ó yes Motion carried. Sarah Crimmins, County Agent, met with the board upon their request to inquire what her secretarial needs were for the Extension office. Crimmins reported a half day would be very helpful. Crimmins will be mentoring with the Ext. Agent in Mohall and has been busy setting up different meetings and programs already.

It was moved by Commissioner Axt to approve the Maintenance agreement with NDDOT, seconded by Commissioner Ehrman. Upon roll call vote ó Axt ó yes, Ehrman - yes, Erdmann ó yes Motion carried.

An application for abatement of 2012 taxes filed by Max Guenther for on property located in the SE4 Section 17, E2NE4 Section 19, NE4 & SE4 Section 20 and NE4 Section 29 all in Twp. 145 R 77 was reviewed and forwarded to the Director of Tax Equalization. A hearing was scheduled for February 5th at 2:00 p.m.

The County Officials and Janitor are therefore requested to requisition to the Board of County Commissioners at their regular meetings for all larger items such as furniture, equipment, etc. that exceeds over \$300.00 and that they have the approval of the purchasing board on all smaller items.
