The Board of Sheridan County Commissioners met at 9:00 a.m. County Commissioners present were Howard Erdmann, Eldon Ehrman, and Michael Axt

Chairman Erdmann called the meeting to order. The minutes of the previous meetings were read and approved as sent in the mail.

The first order of business was to elect chairman. It was moved by Commissioner Ehrman to elect Michael Axt as Chairman of board for the ensuing year, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Axt – yes Motion carried. It was moved by Commissioner Axt to elect Eldon Ehrman as Vice-Chairman of the board for the ensuing year, seconded by Commissioner Erdmann. Upon roll call vote – Axt – yes, Ehrman –yes, Erdmann – yes, Motion carried.

Cynthia Wahl, Tax Director, met with the board to present the 2014 increased ag values of 17.7% and that Sheridan County was in compliance with the soil classification data for 2013

both items are according to the State Tax Commissioner's office. Wahl recommends a 15% ag increase and still be within the State allowed tolerance of 5% until the County Equalization meeting is held. It was moved by Commissioner Erdmann to approve a 15% increase in the ag values, Upon roll call vote – Erdmann –no, –Ehrman – no-, Axt – no Motion declined. Chairman Axt commented that the increase in ag values shifts the tax burden to ag land owners, the State Legislature needs to change their formula in calculating the ag values. It was moved by Commissioner Ehrman to not do any ag increase at this time and let the State Board of Equalization be responsible for the action of increased ag values that they set, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Axt – yes Motion carried.

It was moved by Commissioner Ehrman to appoint Jeff Martwick to the 3rd District County Assessor position covering Sperry and Whittaker Twps. and to re-appoint Mary Feickert, Samantha DeMunbrun, and James Haux for the remaining unorganized twps., seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Axt – yes Motion carried.

Sheriff, Trent Naser, met with the board to report that he is applying for a grant through the oil impact funds that he will be attending a hearing on tomorrow. The grant is for a 2014 expedition and new laptops for the vehicles for a total of \$44,598.00 with a 25% match of \$11,149.50 Naser reported criminal report statistics in his office have tripled from years past with an influx of new people gradually moving in. Naser also inquired about changing the inclement weather policy for closing the courthouse to be up to the County Commissioner Chairman not the Sheriff. It was moved by Commissioner Ehrman to amend the Employee Policy manual by taking out to be contacted by the County Sheriff, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Axt – yes Motion carried.

Herb Bargmann, Wold Engineering, met with the board to review construction engineering services for the north farm to market road from McClusky. Oil impact grant monies will be utilized to upgrade the north farm to market road from McClusky. It was moved by Commissioner Erdmann to approve the Wold Engineering Construction Engineering Proposal for SC-CNOA-4211(063), seconded by Commissioner Ehrman. Upon roll call vote – Erdmann – yes, Ehrman – yes, Axt – yes Motion carried. Road improvements on the north road from McClusky was discussed. The original grade was done in 1955 and the County regraded it in 1966. Surveying won't be done until spring allows so bids will not be let out until possibly the November state bid letting.

Alvin Gross, Road Foreman, met with the board to present an estimate from Jamie Murray, Mercer, of applying blow in insulation on the walls for the Martin County Shop in the amount of \$7,826.00. The estimate was tabled until the February meeting.

The time being 2:00 p.m. the fuel bid letting on the rack price was held. Bids were received from the following:

It was moved by Commissioner Erdmann that Commissioner Axt ask the City of McClusky if they would sand the Farm to Market pavements for a fee, seconded by Commissioner Ehrman. Upon roll call vote – Erdmann – yes, Ehrman – yes, Axt – yes Motion carried.

Janice Erdmann, Treasurer, presented the pledge of assets report. It was moved by Commissioner Ehrman to approve the pledge of assets report as filed in the auditor's office, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Axt – yes Motion carried.

The County Agent narrative for November & December 2013 was reviewed.

The Auditor reported a building permit was issued to Richard Brackett for constructing a 26' x 40' cold storage structure on outlot 4 tract in NE4 10-146-77.

It was moved by Commissioner Ehrman to authorize the Auditor to sign the NRG master technology service agreement, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Axt – yes Motion carried.

It was moved by Commissioner Erdmann to approve the application for abatement of 2013 taxes for homestead credit on Lots 1-2, Lots 5-12, Lots 22-24, Blk. 12, Original, all in Denhoff, seconded by Commissioner Ehrman. Upon roll call vote – Erdmann – yes, Ehrman – yes, Axt – yes Motion carried.

It was moved by Commissioner Ehrman that the District County Assessors be paid \$300.00 per township for assessor duties for 2014, seconded by Commissioner Axt. Upon roll call vote- Ehrman – yes, Axt – yes, Erdmann – yes. Motion carried.

It was moved by Commissioner Erdmann, seconded by Commissioner Ehrman, and carried that the Chairman of the Board, Michael Axt, the County Auditor, and the County Treasurer, be appointed the members of the purchasing board for the ensuing year, 2014. Upon roll call – Axt – yes, Ehrman – yes, Erdmann – yes. Motion carried. The County Officials and Janitor are therefore requested to requisition to the Board of County Commissioners at their regular meetings for all larger items such as furniture, equipment, etc. that exceeds over \$300.00 and that they have the approval of the purchasing board on all smaller items.

It was moved by Commissioner Ehrman, seconded by Commissioner Axt and carried that the Auditor be authorized to pay the following items by Auditor's warrants during the year upon authorized payrolls, workmen compensation premiums, unemployment insurance, withholding tax, and county shop, county park, and courthouse electricity and water bills.
