It was moved by Commissioner Axt to cancel the Kenneth Vos weed mowing bill in the amount of \$250.00 as per requested by the land renter and Strassburg Twp board seconded by Commissioner Erdmann. Upon roll call vote – Axt – yes, Erdmann – yes, Eisenbeisz – yes Motion carried. The Auditor was instructed to send a letter to the Strassburg Twp Board stating that if Strassburg twp roads are not repaired and mowed the County will not do any blading or snow removal on Strassburg Twp. roads in the future.

Sheriff Trent Naser, met with the board to discuss the new Sheriff's clerk 4/5 salary for Sheila Faul. It was moved by Commissioner Axt to set the new Sheriff's clerk monthly salary at \$1,466.92 for

2016, seconded by Commissioner Erdmann. Upon roll call vote – Axt – yes, Erdmann - yes, Eisenbeisz – yes Motion carried. Sheriff Naser also reported on the vehicle police radios that one of the radios had to be completely redone. Parts are getting hard to find being they are over 5 years old. A replacement radio plan needs to be in place to replace radios over time. The suggestion of when a new police vehicle is budgeted that a new radio should also be in the budget at the same time to keep up with having a reliable radio. It was moved by Commissioner Erdmann to approve purchasing one new radio if need be for the new 2016 Sheriff's vehicle, seconded by Commissioner Axt. Upon roll call vote – Erdmann – yes, Axt - yes, Eisenbeisz – yes Motion carried.

Justin Owen, Site Development Services rep for Verizon Wireless, was on speakerphone upon Commissioners request to discuss the conditional use permit that was approved February 4, 2014. Owen reported that the new guidelines are now not to build a structure to house the generator and equipment inside but rather to just install an outdoor cabinet on a platform instead. The board waived refiling an application for a conditional use permit for just that change. Also the board recommended Owen to speak with our engineer on the north road project from McClusky so if Verizon needs an approach that would be the time to construct it. Owen stated to send him an email or letter with info on the road project and engineer info. The Commissioners asked when the cell phone tower will be erected. Owen stated it is in the 2016 budget, however; it all depends on the spectrum of FCC changes.

The board instructed the Auditor to investigate into a digital recorder for recording County Commission minutes.

Lynnette Fox, County Treasurer, met with the board to present the pledge of assets report for the County securities. It was moved by Commissioner Axt to approve the pledge of assets report as filed in the county auditor's office, seconded by Commissioner Erdmann. Upon roll call vote - Axt - yes, Erdmann – yes, Eisenbeisz –yes Motion carried. Fox reminded the board she will be on vacation January 21^{st} thru Feb 7^{th} and Janice Erdmann will fill in as needed during that time period.

Cynthia Wahl, Tax Director, and Janice Erdmann, met with the board to discuss the assessing duties and state requirements. Wahl stated each assessor has two years to get their 80 hours of classes in. Jefferey Martwick, McClusky City & Goodrich City assessor has done 40 hours of the classes so far and has one more year to complete the other half of classes. Wahl reported Mary Feickert will continue assessing and will complete the 80 hours of training. Chairman Eisenbeisz will contact the organized twps. that do not have an assessor to see what their plan is. Wahl is available to do assessing on organized twps. and unorganized twps. The County assessing rate will be \$300.00 per twp. that will be added to Wahl's salary for the unorganized twps. and based on the number of organized twps. that hire Wahl to complete the assessments will then be added also to her salary. Wahl stated that according to the State Tax Commissioners office, Sheridan County should raise the average ag values by 15.2% in order to be equalized statewide. It was moved by Commissioner Axt to approve increasing the ag values only by 6% rather than the 15.2% and still be within the 10% tolerance allowed by the State Tax Commissioner's Office, seconded by Commissioner Erdmann. Upon roll call vote – Axt –yes, Erdmann –yes, Eisenbeisz – yes Motion carried.

Nicole Wardner, County Agent, met with the board to present her narrative report. The succession classes (Transitioning the family farm legacy to the next generation) were attended very well the week of Thanksgiving and her office will be offering them again next fall. Wardner held a holiday decorating class with evergreen arrangements that was attended by 28 participants. Community projects were focused on by the 4-H club and 4-H livestock judging will start next week. The Fall Fling was held in partnership with the Sheridan County Soil Conservation District with over 45 participants attending that learned about gardening projects and winter landscaping. Wardner inquired about the Sheridan Association meeting/banquet. Commissioner Axt stated to set up a meeting and let the board decide any actions. In-service meetings in Washburn and Minot will be attended by Wardner. Pesticide training will start up soon again also. Wardner stated there is a harmony in the workplace class offered thru NDSU that could be done at the courthouse if so desired. No action was taken. There was a number of SCIPY events held that included the fundraising ham dinner, a winter clothing drive for school kids, and Santa Store for Santa day. The next SCIPY meeting is February 17th and on the agenda is organizing the SCIPY supplies in the Courthouse boiler room.

Alvin Gross, Road Foreman, met with the board to report on repairs of the Payloader will be done soon and the rear window in Byron Belile's motorgrader was broke out by rocks flying up while blading. Gross reported he is also still trying to find a rim for the 1976 International truck.

Letters were sent to the two fuel vendors in the County that participated in the fuel bids in the past years, as instructed by the board, for any input if bid discounts and delivery arrangements can stay the same as in the past. Being there were no objections, it was moved by Commissioner Axt to approve the same discount and fuel arrangement as in the past with the Co-op Elevator, McClusky and Konschak

Oil Inc., Goodrich, for 2016 for any County fuel orders, seconded by Commissioner Erdmann. Upon roll call vote – Axt – yes, Erdmann – yes, Eisenbeisz – yes Motion carried.
