## County Commission Meeting April 3, 2007

The Board of Sheridan County Commissioners met at 9:00 a.m. Commissioners present were Shirley J. Jorgensen, Howard Erdmann, and Eldon Ehrman.

Chairperson Shirley J. Jorgensen called the meeting to order. The minutes of the previous meeting was read and approved.

Upon roll call vote – Ehrman – yes, Erdmann – yes, Jorgensen - yes Motion carried. Naser reported that Mercer County backed out of the Narcotic Task Force and the Task Force is looking for a County to sponsor a new agent and the County would be reimbursed for salary and

benefits. Naser suggested to wait out the rest of this year and see how service call time from the Narcotic Task Force will be. Commissioners recommended to Naser to investigate the costs of joining the Narcotic Task Force in McHenry and Pierce Counties.

It was moved by Commissioner Ehrman to approve the McClusky Merchants, Inc. Gaming site authorization to be held at the Union Grill and Bar, McClusky, effective 07-01-07 thru 06-30-08, seconded by Commissioner Erdmann. Upon roll call vote – Ehrman – yes, Erdmann – yes, Jorgensen – yes Motion carried.

County Agent, Crystal Schaunaman, presented her January-March narrative reporting on the County Extension activities that included information discussed at the annual Sheridan Assoc. meeting in December, the Ag Forum on February 20<sup>th</sup>, and seed sales by the Sheridan Association. Also the Multiple Planning Unit 7 Crop Day at the Carrington Research Extension Center in December was attended by Schaunaman and she will be helping evaluate the upcoming no-till tour held June 19 at the Dakota Lakes Research Farm. Pesticide and fumigation certification classes were held in February with 10 private and 9 fumigation certificates that were administered. A Fun Day with 4-H members was held on Feb 19<sup>th</sup> to bake cookies and pizzas. Annie's project (Women in Agricultural) wrapped up on March 7 with a successful attendance of 16 women. Car seat inspections were done in partnership with SCIPY and First District Health.

Family Nutrition Program Agent, Julie Hudson-Schenfisch, report was read that included attending School visits introducing food groups along with exercise and general health lessons and assisting the County Nurse with WIC clients on providing them nutrition education lessons.

The Soils Committee members were discussed further with the Tax Director, Cynthia Wahl. It was moved by Commissioner Ehrman to appoint the following to the Sheridan County Soils Committee for tax purposes, seconded by Commissioner Erdmann. Upon roll call vote: Ehrman – yes, Erdmann – yes, Jorgensen – yes Motion carried.

It was moved by Commissioner Erdmann to rescind the motion from the March 6<sup>th</sup> meeting stating \$10.00 per meeting for Soils committee and being paid out of each road district or organized township, rather to \$35.00 per meeting plus mileage that will be paid out of the County General fund, seconded by Commissioner Ehrman. Upon roll call vote – Erdmann – yes, Ehrman – yes, Jorgensen – yes Motion carried.

The time being 2:00 p.m. the hearing on the abatement of 2006 taxes filed by Ruth Sauter for the E2 of Lot 7, all of Lots 8-9-10, Blk. 2, Grethens, Goodrich City, was held. No one was present. It was moved by Commissioner Erdmann to approve the 2006 abatement due to Sauter is eligible for 100% Homestead Credit, seconded by Commissioner Ehrman. Upon roll call vote – Erdmann – yes, Ehrman – yes, Jorgensen – yes Motion carried.

Walter Filler, Sheridan County Rural Water Board Chairman, met with the board to report their Water Board Treasurer, Alvin Herr, is disagreeing with paying annual ND State Water Membership dues. The Board recommended to have a meeting and make a motion to the effect to compensate the bill.

Alvin Gross, Road Foreman, met with the board to discuss issues on blading roads. Tires for the International gravel truck were priced out. It was moved by Commissioner Erdmann to

purchase (4) 14 ply tires for \$132.95 each from Good Year Tires, seconded by Commissioner Ehrman. Upon roll call vote – Erdmann – yes, Ehrman – yes, Jorgensen – yes Motion carried.

The Auditor reported Johnston Fargo culvert prices have increased by 18% from last year. New prices will be discussed further at next months meeting.

There being no further business the meeting adjourned.
