County Commission Meeting November 3, 2015

The Sheridan County Commission met at 9:00 a.m. Commissioners present were Howard Erdmann, Steve Eisenbeisz, and Michael Axt. Others present: Sandy Blanes, McClusky Gazette reporter

Chairman Erdmann called the meeting to order. The minutes of the previous meetings were sent in mail and approved as sent.

Sheriff, Trent Naser, met with the board to discuss the emergency burn ban process and the issues trying to enforce it. Naser recommended continuing with the statewide rangeland burn ban that can be enforced. No grants were found for the radio repeater. It was moved by Commissioner Axt to approve purchasing a repeater for \$2,100.00, seconded by Commissioner Eisenbeisz. Upon roll call vote – Axt – yes, Eisenbeisz – yes, Erdmann – yes. Motion carried. Naser was inquiring about new computers in the Sheriff's vehicle being they are 6-7 years old and are at the end of their use. Naser requested purchasing a Panasonic Toughbook 53 (laptop) that is more reasonable price that McLean County deputies also have in the amount of \$2,285.00. It was moved by Commissioner Eisenbeisz to approve purchase of the Panasonic Toughbook, seconded by Commissioner Axt. Upon roll call vote – Eisenbeisz- yes, Axt – yes, Erdmann – yes Motion carried.

Dan and Jeanie Sobieck, landowners, met with the board to review the agenda and get info to better prepare for the upcoming public forum on road improvement funding and issues with the District #7 legislators on Thursday, November 19, 2015 at the Courthouse community room from 6:30 p.m. to 8:00 p.m.

The time being 10:00 a.m. the bid letting for selecting grading, milling, widening, blended base, bituminous surfacing and chip sealing the 5 miles north of McClusky was conducted in the Courthouse Community Room. Herb Bargman and John Martin, Wold Engineering, met with the board to report that the bids were re-calculated and were correct on final totals submitted. The lowest bid was received from Knife River Materials, MN. It was moved by Commissioner Axt to approve the lowest bid of \$2,945,298.79 from Knife River materials, MN, seconded by Commissioner Eisenbeisz. Upon roll call vote- Axt – yes, Eisenbeisz – yes, Erdmann – yes Motion carried.

It was moved by Commissioner Axt to authorize the Chairman to sign the DOT federal aid road form with no projects scheduled for federal aid in the next year, seconded by Commissioner Eisenbeisz. Upon roll call vote – Axt – yes, Eisenbeisz – yes, Erdmann – yes Motion carried.

The Auditor reported the Metlife Life Insurance and Disability premiums that the County provides as a benefit for County employees will see no increase for next year.

It was moved by Commissioner Eisenbeisz to retain the 2011 unspent disaster monies that will be documented to spend on hazard mitigation items by October 20th, 2016, seconded by Commissioner Axt. Upon roll call vote – Eisenbeisz – yes, Axt – yes, Erdmann – yes Motion carried.

Wayne Houston, Emergency Manger, met with the board to report the batteries in both the McClusky and Denhoff sirens are dead and need to be replaced. Houston recommended to replace batteries at \$126.95 each with each siren needing two batteries plus the installation cost. Costs will be taken out of the HPCR fund. Houston also reported he attended the table top emergency exercise workshop last week in Fargo.

The time being 1:30 p.m. the hearing on the appraisal of land forfeited to the County was held. There being no entities present the minimum sale prices were left as set. The forfeited land sale will be held at 10:00 a.m. November 17th, 2015.

The Auditor was instructed to apply a special assessment of \$62.50 for mowing weeds in 2014 along road right of way in the NE4 11-148-78.

The Auditor presented the new 2^{nd} cut road mowing bills that will be sent out to the landowners this month.

The Auditor reported an ad for hiring the County Treasurer was sent to the McClusky Gazette with the closing date of accepting applications as of Friday, November 13th. The board will have a special meeting on Tuesday, November 17th at 1:00 p.m. to interview County Treasurer applications.

Alvin Gross, Road Foreman, met with the board to discuss ordering the new 6 ton load restrictions signs in 18"x 24"size and going with 12' telespar metal poles for installing the signs on instead of the wood poles. The board agreed with recommendations. Other road issues were discussed also.

The time being 6:30 p.m. at the Courthouse Community room a public forum on rural road funding was conducted by moderators Daniel and Jeannie Sobieck, rural landowners in Sheridan County. County Commissioners Howard Erdmann and Steven Eisenbeisz were present. Absent: Michael Axt Others present were: Legislative #14 District representative, Jerry Klein, Jon Nelson, and Robin Wiesz; Pierce County Commissioners, Duane Johnston and Michael Christianson; Road Foreman, Alvin Gross; Blade operators, Michael Hoffman and Byron Belile; property owners, Norman & Lynnette Boehm, Elmer Laib, Jerone Sauter, Wayne Helm, James Haux, Jeff Martwick, Janice Erdmann, and McClusky Gazette Reporter, Sandy Blanes.

Daniel Sobieck introduced themselves that their background between the two of them consisted of 50 years of working with the public for the USDA offices. Mr. Sobieck presented the agenda and shared slides of photos of the road conditions from the spring in Sheridan County. The blade men spoke up that the sites have been repaired since then. Mr. Sobieck stated they do not want anyone to be offended they only want answers on how to receive more road funding so roads don't get like they were in the spring.

Mr. Sobieck asked the group if there were emergency responses that have not been met in Sheridan County due to poor road conditions. The response was - so far the fire trucks and ambulances have been lucky according to Jeff Martwick. The farm to market roads is the main concern to keep them maintained as they are the main arteries in the County stated Chairman Erdmann.

Mr. Sobieck asked the group if the roads were better 10 years ago and why. Chairman Erdmann responded that grain trucks were smaller and now it is semi-trucks on all twp. roads that are not built to handle heavy equipment as there is now. Pierce County Commissioners stated it is the same way in their county. Some of their roads they have closed to detour a couple miles around instead of the straight mile across, due to not enough funding to repair roads and common sense of the cost verses another mile or two detour until water recedes, etc. Senator Jerry Klein stated Sheridan County is not by itself in the State in the road funding issue. Wells County also has road closures and road issues too. Since 1993 when the rains started the water table has been rising every year since then, however; Devils Lake is finally down 4ft now stated Rep. Nelson. Legislator Weisz stated the shift from producing wheat to more corn also makes more weight on the roads now than it did 10 years ago also.

Funding from the oil surge bills that were approved in the last legislative sessions was discussed and what was approved for Sheridan County. The Sheridan County Commissioners stated that the 5 miles going north from McClusky is getting upgraded and repaved next year with the oil surge bills.

Mr. Sobieck asked the legislators what the Legacy fund can be used for in 2017. Senator Klein stated only the interest from the Legacy fund will be available which is at 3 billion currently that can be used for emergency needs or a shortfall in budget needs. If oil goes back up to where it was last year then more state monies can be distributed out to continue upgrading infrastructure throughout the state.

Daniel and Jeannie Sobieck presented a draft 5 yr. road funding plan of 4.85 million each year for Sheridan County in order to meet current road needs. Rep. Nelson stated that the state will not be able to meet near the draft plan amount. Rep. Weisz also stated the urban counties don't care about rural county roads. Senator Klein stated they just don't know what the future will bring with the oil production down now.

Mr. Sobieck asked the legislators where Sheridan County goes from here to find funding for meeting current road needs. Rep. Nelson stated three ideas would be to pass an increase on fuel tax in turn that would come back to the Counties and townships, offer low interest loans from Legacy fund, and urge Congress to pass a reliable federal transportation bill asap. An individual asked if game and fish funding can be tapped into with hunters driving around wrecking the roads esp. when wet. The legislators replied that they had tried many
