COUNTY COMMISSION MEETING January 6, 2004

The Board of County Commissioners met at 9:00 a.m. Commissioners present were Eldon Ehrman, Shirley J. Jorgensen, and Howard Erdmann.

Chairman Ehrman called the meeting to order. The minutes of the previous meeting was read and approved.

Alderin will teach a fumigation course in January that will be conducted at the Courthouse that the CO-OP Elevator of McClusky will sponsor. The cattle market with the mad cow disease was discussed.

At this time William Engen and Reuben Miller, former New Germantown Twp. Officials, met with the board to turn in twp. Minutes and official documents leftover from organized New Germantown twp. to the County now that it has been dissolved. New Germantown Twp will make final payments on bills they owe and turn checkbook over to County with a zero balance. New Germantown Twp. assessor will now be the 1st District Assessor which is James Haux.

Cynthia Wahl met with the board to present agriculture values for 2004 from the ND State Tax Commissioners Office and to discuss upcoming abatements. It was moved by Commissioner Erdmann to approve no change be made on agriculture values from last year according to the ND State Tax Commissioners Office, seconded by Commissioner Ehrman. It was moved by Commissioner Ehrman to appoint Howard F. Erdmann on the Social Service Board to replace Phyllis Dockter due to county policy procedures, seconded by Commissioner Erdmann. Upon roll call vote -Ehrman - yes, Erdmann - yes, Jorgensen - yes All voting "yes" the motion carried.

It was moved by Commissioner Ehrman to authorize the Auditor's office to attend the HAVA Election workshop on January 13th in Bismarck, seconded by Commissioner Erdmann. Upon roll call - Ehrman - yes, Erdmann - yes, Jorgensen - yes All voting "yes" the motion carried.

Larry Gessner, Sheriff, met with the board to discuss the City/County Policing contract. It was moved by Commissioner Ehrman to approve the City/County Policing contract for 1 year at \$12,500.00, seconded by Commissioner Erdmann. Upon roll call vote - Ehrman - yes, Erdmann - yes, Jorgensen - yes All voting "yes" the motion carried.

It was moved by Commissioner Erdmann to approve repairing the rearend and transmission on the Sheriff's Office Bronco, seconded by Commissioner Ehrman. Upon roll call vote - Erdmann - yes, Ehrman - yes, Jorgensen - yes All voting "yes" the motion carried.

It was moved by Commissioner Ehrman to approve to purchase a 2001 Ford Crown Victoria from Salt Lake County Fleet in the amount of \$13,000.00 that has 31,646 miles on and that the Sheriff's office will drive to Salt Lake City to pick the vehicle up, seconded by Commissioner Erdmann. Upon roll call vote - Ehrman - yes, Erdmann - yes, Jorgensen -

It was moved by Commissioner Ehrman to hire Faye Axt as a part time Deputy Sheriff for 20 hrs a week at 875.00 per mth. effective January 5, 2004, seconded by Commissioner Erdmann. Upon roll call vote - Ehrman - yes, Erdmann - yes, Jorgensen - yes All voting "yes" the motion carried.

It was moved by Commissioner Erdmann to purchase a grantor/grantee software program for the County Recorders Office that enables the public access of recordings and searches over the internet for a fee from Computer Service Associates, Inc. in the amount of \$6,735.00 to be paid over a two year period with annual support maintenance of \$1,350.00, that is included over the two year period purchase price, seconded by Commissioner Ehrman. Upon roll call vote - Erdmann - yes, Ehrman - yes, Jorgensen -yes All voting "yes" the motion carried. The fees collected by Computer Service Associates, Inc. through the Internet are transferred back to the County.

The Boiler Insurance Policy for 2004 was reviewed and approved.

It was moved by Commissioner Ehrman that the District County Assessors be paid \$275.00 per township for assessor duties, seconded by Commissioner Erdmann. Upon roll call vote Jorgensen - yes, Erdmann - yes, Ehrman - yes All voting "yes" the motion carried.

It was moved by Commissioner Erdmann, seconded by Commissioner Ehrman, and carried that the Chairman of the Board, Shirley Jorgensen, the County Auditor, and the County Treasurer, be appointed the members of the purchasing board for the ensuing year, 2004. Upon roll call - Erdmann -yes, Ehrman - yes, Jorgensen - yes All voting "yes" the motion carried. The County Officials and Janitor are therefore requested to requisition to the Board of County Commissioners at their regular meetings for all larger items such as furniture, equipment, etc. that exceeds over \$100.00 and that they have the approval of the purchasing board on all smaller items.

COUNTY COMMISSIONERS MEETING January 22, 2004

The Board of County Commissioners met at 10:00 a.m. in special session. County Commissioners present were Shirley J. Jorgensen, Eldon Ehrman, and Howard Erdmann

Other present: Allan Tinker

Chairperson Jorgensen called the meeting to order.

County Auditor, Shirley A. Murray, reported on the Help America Vote Act (HAVA) that requires optical scan voting equipment at each polling place to allow the voter a second chance of voting in case of overvote or crossover vote and to have handicapped voting equipment available also at each polling place. HAVA is effective by January 1, 2006. The new optical scan equipment will be taking place this 2004 Election year and the handicapped voting equipment will take place prior to January 1, 2006 in most counties across North Dakota. Also consolidating down to 4 polling places from 6 polling places in Sheridan County being the new Model 100 optical scan voting equipment can scan and tabulate votes for two legislative districts in one polling place was discussed. Sheridan County did have 4 polling places prior to the year 2000 legislative redistricting, then Sheridan County was split into two legislative districts, therefore; adding two more polling places was needed then. If Sheridan County does not consolidate down to 4 polling places the County will have to pay the full price of the optical scan voting equipment for 2 polling places. Consolidating the

polling places down to 4 was tabled until the February Meeting. The new voting equipment and software will cost the County around \$250.00 per polling place for up to only 4 polling places from Election Systems & Software, MN, after the State and Federal have paid their share. ES&S will trade-in the old III-P Eagle optical scanning voting equipment for \$150.00. The new machines will be delivered late March, 2004. Regional training on the new voting equipment for the Auditor's office and poll workers will be held in March/April. The Auditor stated that the oval next to the candidate's name will need to be completed with the new optical scanning equipment in order to vote for your candidate's choice rather than connecting the arrow to your candidate's choice as has been Including the Cities and School offices/measures and done in the past. candidates on the County ballot was discussed. It was moved by Commissioner Erdmann that the County absorb the costs of programming the ballots to include the City and School candidates to be on the County ballots upon approval of agreement by the Cities and Schools seconded by Commissioner Ehrman. Upon roll call vote - Ehrman - yes, Erdmann - yes, Jorgensen - yes All voting "yes" the motion carried.

The auditor reported that the Twp Clerks/Treasurers need to report social security & medicare to the IRS when compensating their elected officials. An IRS workshop has been scheduled for the Twp. Clerk/Treasurers at the Community Room in the Courthouse on February 23, 2004 at 1:00 p.m. to inform them of the procedures and forms to report.
