County Road Foreman, Ed Baker, met with the board to report that he his back to working half days now. Baker reported road blading classes will be available this fall for the road crew to attend.

Gordon Felchle and Elmer Knodel, Water Resource Board, met with the board to discuss the Upper Sheyenne Water Resource District Plan. Felchle and Knodel will be attending other meetings in Minot and Medora to receive more information on developing a plan for the Upper Sheyenne Water Resource District.

The time being 11:00 a.m. the County Park Board met. The County Commission meeting reconvened at 1:00 p.m.

At this time County Commissioner Howard Erdmann joined the meeting.

The time being 1:00 p.m. Paul Rechlin and Brent Eckstrom with Lewis and Clark Regional Development Council met with the board. Also present were McClusky City Mayor, Melvin Schindler, and Lewis & Clark RDC committee members, Robert Sorenson, John Davis, and Darvin Engel. Rechlin stated the revolving loan fund that was created in 1993 is dwindling down and is in need of more contributions to help fund new business's and grant writing, etc. Sheridan County's return of local money of \$9,000.00 brought in over \$900,000 in grants and loans for Sheridan County alone. Rechlin requested \$7,200.00 from the County Commissioners. Jorgensen requested the City of McClusky to participate with a contribution for the revolving loan fund with L&CRDC being McClusky City has received funding from the revolving loan fund. Schindler will address the McClusky City Council on this issue. Sorenson stated the First National Bank of McClusky will commit \$1,000.00 towards the revolving loan fund. It was moved by Commissioner Ehrman to approve committing the \$7,200.00 that will include contributions from the local banks and communities, seconded by Commissioner Erdmann. Upon roll call vote - Ehrman - yes, Erdmann - yes, Jorgensen - yes All voting "yes" the motion carried. Jorgensen

will contact Choice Financial Bank of Goodrich and Erdmann will contact the City of Goodrich for participating in contributing to the revolving loan fund.

At this time Greg O'Shea, Butler Machinery, met with the board to present estimates on new payloaders. No action was taken at this time. O'Shea will further investigate on estimates of used payloaders and return back for the next regular Commission meeting. Edward Baker, Road Foreman, met with the board to discuss road matters and 911 signs to be installed on the main County roads. Baker will contact Wayne Houston, Emergency Manager, to work on the 911 signing project together.

At this time Annie Fylling, Extension Office, introduced the new Sheridan County Agent, Crystal Schaunaman, that will start working in the Extension office, Monday, July $12^{\rm th}$.

It was moved by Commissioner Ehrman to approve the State Fire and Tornado Insurance Policy for all the County buildings, seconded by Commissioner Erdmann. Upon roll call vote - Ehrman - yes, Erdmann - yes, Jorgensen - yes All voting "yes" the motion carried.

An application for abatement or refund of taxes filed by Diane Hintz for the NE4,NW4, SW4 Section 27 -148-74 was reviewed and forwarded to the Tax Director. The hearing for abatement of taxes was set for August $3^{\rm rd}$, 2004 at 2:00 p.m.

There being no further business the meeting adjourned.

COUNTY COMMISSION MEETING July 13, 2004

The Board of County Commissioners met in special session at 9:00 a.m. on call of the Chairperson. County Commissioners present were Shirley J. Jorgensen, Eldon Ehrman, and Howard Erdmann Also present was Ed Baker, Road Foreman.

Chairperson Jorgensen called the meeting to order. Chairperson Jorgensen stated the purpose of the special meeting was to discuss hiring another blade operator, due to Aaron Stein has resigned.

Fylling reported that the showers in the bathrooms in the new 4-H building were really utilized by campers last weekend and with black dirt in front of the new building created a mess on the floor. The black dirt will be roped off for Achievement Days. Mike Colby will have the contracted plumber redo shower plumbing to place shower on short wall and shower timers installed to allievate creating a water mess on the floor. Steve Murray and Ron Almer have completed kitchen area except repairing the counter top and installing shelving that will be done later. Painting on the pillars and trim on the building has been completed by Bonnie Helm. Everyone was encouraged to attend the 4-H Achievement days July 15-16-17 at the Hoffer Lake recreation area with appreciation supper held on the 16th.

The Pledge of Assets were reviewed at this time and approved as is with sufficient coverage.
