The County equipment schedule rates and culverts prices were reviewed and will be updated to the new increased prices.

Larry Gessner, Sheriff, met with the board to discuss criminal issues. Commissioners suggested to change voice mail message with home phone #'s included for assistance. Deputy shifts were discussed. Arlington Helm, County Park Board member, met with the board to receive authorization to install extra valves at the new County 4-H building for draining the water in the fall. It was moved by Commissioner Ehrman to authorize Helm to install extra valves in the new building at Hoffer's Lake Recreation Area to help drain the water better so pipes don't freeze up for the winter, seconded by Commissioner Erdmann. Upon roll call vote - Ehrman - yes, Erdmann - yes, Jorgensen yes All voting "yes" the motion carried.

The time being 9:30 a.m. the Housing Authority Board members met in conjunction with the County Commission meeting. Members present were Thomas Sauter, Arthur Waltz, and Armin Erdmann. Absent: Lloyd Bauer and Clifford Dockter

The minutes of the previous Housing Authority meeting was read and approved.

Newly appointed Marsha Schneider, Wells-Sheridan Housing Director, Harvey, met with the board to present the 2003 report as follows:

The total housing assistance paid out in 2003 was \$48,232.00. There were only 21 families receiving assistance in the last three months of 2003. Four of these families were from Sheridan County and 17 from Wells County. By January 1, 2004, one of the families from Sheridan County no longer qualified for assistance, and another moved to Bismarck, for a total of 19 families: 3 from Sheridan County and 22 from Wells County. Currently there are six families on the waiting list, one from Sheridan County and 5 from Wells County.

Schneider stated the Denver Office will be auditing her files and spot tenant inspections due to reports were not filed on time because of her computer having a virus. A separate computer will possibly be purchased for just the Housing Authority Office in her home.

Schneider reported the Administrative Plan is being reviewed for prioritizing for elderly versus younger applicants. Schneider will discuss changing Adm. plan with the Denver office and get back to us if we need to have a special meeting for approving a new Adm. Plan. Borrowing housing vouchers from another County who have extra housing vouchers can also be done. Budget can be revised also.

Schneider presented the new Housing Assistance brochures to the board for review.

It was moved by Housing Authority member Arthur Waltz to re-appoint Thomas Sauter as Chairman and re-appoint Armin Erdmann as Vice-Chairman for the Housing Authority Board for 2004, seconded by Commissioner Ehrman. Upon roll call vote - Waltz -yes, Sauter - yes, Erdmann - yes All voting "yes" the motion carried.

There being no further business the Housing Authority Board adjourned.

The County Commission Meeting reconvened at 10:15 a.m.

At this time Joshua Baker, McClusky, met with the board to be interviewed for employment of operating Motorgrader equipment for the County. Baker's application was reviewed and questions were presented and answered. Baker was informed that due to nepotism, he could not be

hired at this time, however; to apply again in the future when employment changes.

The time being 1:00 p.m., Kenneth Konschak, Goodrich, met with the board to be interviewed for employment of operating Motorgrader equipment for the County. Konschak's application was reviewed and questions were presented and answered.

The time being 2:00 p.m., Leonard Marquart, Anamoose, met with the board to be interviewed for employment of operating Motorgrader equipment for the County. Marquart's application was reviewed and questions were presented and answered.

At this time the Courtroom was examined by the Commissioners for improvements that need to be done for noise reduction. Installing carpet on the North wall and partially on the floor was suggested. Sundre Gravel, Minot, was contacted by speakerphone for crushing gravel in some pits in the County that are getting used up. The Road Foreman was instructed to conduct gravel testing at gravel pit sites and crushing gravel prices will be considered then.
