Rules and Regulations

Please observe the following rules so your stay may be enjoyable.

VEHICLES

This section pertains to all vehicles, including, but not limited to automobiles, trucks, motorcycles, mini bikes, snowmobiles, ATVs and trailers, campers, bicycles, or any other such equipment.

The operation and/or parking of a vehicle off authorized and designated roadways is **PROHIBITED** except at locations and times designated by the Sheridan County Park Board.

No person shall operate any vehicle in a careless, negligent or reckless manner so as to endanger any person, property or environmental feature. All operators will be expected to obey all posted regulations.

At all developed recreation areas, vehicles shall be used only to enter or leave the area or individual sites and facilities



BOAT RAMP USE

Boat ramp users shall obey posted regulations with regard to loading and unloading of all water craft.

Parking of vehicles and boat trailers shall be restricted to posted areas only. Citations will be issued to owners/operators of any vehicle violating parking restrictions.

Anglers camping within the park are requested

to return vehicles and trailers to camp sites whenever possible to help avoid congestion in parking areas used by non-camping anglers.

No parking on the boat ramp after water craft has been launched.

Individuals using kayaks or paddleboats are encourage to access North Hoffer Lake.

CAMPING

Camping is permitted only at sites or areas designated by the Sheridan County Park Board and posted by signs and/or marks.

The maximum amount of time that you may camp at a campsite is 14 consecutive days.

The unauthorized placement of camping or other items at any campsite without overnight occupancy for the purpose of reserving a designated campsite for future occupancy is **PROHIBITED**.

The digging or leveling of any ground at any campsite without permission of Sheridan County Park Board personnel is **PROHIBITED**.

Pets must be on a leash no longer than 10-feet and must not be a nuisance or a danger to other campers or the general public.

SANITATION

Regulations for disposal of waste and garbage is simple. YOU BROUGHT IT IN, YOU PACK IT OUT.

It is **PROHIBITED** to dump any fish or bird remains in dumpsters.

FIRES

Fires shall be confined to designated areas, and shall be contained in fireplaces, grills or other facilities designated for this purpose.

Pallets and garbage are not to be burned in firepits.

MISCELLANEOUS

Personal **FIREWORKS** of any variety are **PROHIBITED** on Federal lands.

Cutting or gathering of trees or parts of trees and/or removal of wood from parks and recreation sites is **PROHIBITED**.

Glass containers are **PROHIBITED** in recreation areas.

11:00 p.m. - 7:00 a.m. is considered "quiet" hours within the park.

Additionally, applicable State and local laws and regulations remain in full force. Conviction will result in the required payment of \$50 court costs together with a fine up to \$1,000 or more.

CAMPING FEES and RESERVATIONS

A \$25.00 camping fee per night is required for all overnight camping sites with power and water.

A \$15.00 camping fee per night is required for all primitive camping areas.

A \$5 camping fee per night is required for tent camping.
