The Board of Sheridan County Commissioners met at 9:00 a.m. County Commissioners present were Eldon Ehrman, Howard Erdmann, and Michael Axt

Chairman Ehrman called the meeting to order. The minutes of the previous meetings were approved as sent in the mail to the board.

Susan Ebach, County Nurse, met with board to report that flu shots are available now. It was moved by Commissioner Erdmann that the County pays for any unpaid portion of flu shots for the County employees that the health insurance does not cover, seconded by Commissioner Axt. Upon roll call vote – Erdmann – yes,

The Auditor reported on the States Attorney's opinion that an easement is needed for fiber optic right of way in order to place fiber optic lines down county or twp roads, including section lines, before those lines can be lawfully placed in the ground.

James Waldo, met with the board to introduce himself as the new BCI agent for the Sheridan County area.

The time being 10:00 a.m. Olena Walleen could not attend the meeting, however called in and was on speakerphone to discuss the property described as Lots 6, 7, 8, & 9, Blk. 3, Jasman's Addition Goodrich City that they have a Contract for Deed with the County since August 7, 2008 in the total amount of \$5,000.00 with payments at \$200.00 per mth.. Walleen was in question about property being surveyed and prior owner still saying they own the property. The board reviewed the property boundaries and surveying was up to them to conduct. The payment schedule with Walleen was reviewed and the board stated the contract should have been paid up two years ago, however; payments have not been made on a monthly basis. The County has over extended the payment schedule too long already. The board requested if the remaining amount of

\$2,450.00 is not paid up by September 21, 2012 an eviction notice will be sent. It was moved by Commissioner Axt to approve starting the eviction procedure by September 21st, 2012 if the Contract for Deed is not paid in full by then, seconded by Commissioner Erdmann. Upon roll call vote – Axt – yes, Erdmann – yes, Ehrman – yes Motion carried.

James Haux, landowner, met with the board to request gravel placed on his twp road.

Wayne Houston, Emergency Manger, met with the board to present a 911 Fee resolution. It was moved by Commissioner Erdmann to adopt the following resolution, seconded by Commissioner Axt. Upon roll call vote – Edmann – yes, Axt – yes, Ehrman – yes Resolution was declared adopted.

SHERIDAN COUNTY, NORTH DAKOTA RESOLUTION TO INCREASE THE EXISTING EMERGENCY SERVICES COMMUNICATIONS (9-1-1) FEE

WHEREAS, the emergency services communication (9-1-1) system is critical to public safety in Sheridan County; and

WHEREAS, the monthly fee on "assessed communications services" (telephone exchange access service, wireless service, active prepaid wireless service, and voice over internet protocol service) imposed pursuant to North Dakota Century Code 57-40.6 is essential to the operation and maintenance of the emergency services communication system (9-1-1); and

WHEREAS the current fee limited to \$1.00 per month per "communication connection" (telephone access line, wireless access line, unique voice over internet protocol service connection, or functional equivalent uniquely identifiable by a number, internet address, or other designation) was implemented by resolution of this board and approved on November 8,1994 by the voters of Sheridan County;

WHEREAS the revenue from the current fee is insufficient to adequately fund the maintenance and operations of the emergency services communications (9-1-1) system, it is proposed that the fee maximum be increased to \$1.50 per "assessed communication service" however the county commission could impose an amount less, but no more than that maximum; and

WHEREAS, North Dakota Century Code section 57-40.6-02 provides a process of imposing 9-1-1 fees by governing board resolution and approval of the voters.

THEREFORE, BE IT RESOLVED that the Sheridan County Board of Commissioners proposes an increase of the existing monthly fee, and directs that the following measure be placed on the county ballot for the statewide general election scheduled for November 6, 2012 and shall become effective January 1, 2013.

BE IT FURTHER RESOLVED, that the fee shall be collected by the "assessed communications service providers" and paid to the County within thirty (30) days after collection from the subscriber or customer unless the provider has fewer than ten subscribers or customers in a jurisdiction, in which case the provider may pay the proceeds quarterly. An assessed communications service provider may retain the actual costs of administration in collection of the fee, not to exceed five percent of the fee collected.

County Commission Meeting September 20, 2012

The Board of County Commissioners met at 1:30 as per notice stated. County Commissioners present were Howard Erdmann and Eldon Ehrman. Absent: Michael Axt Others present were: County employees, Joyce Dockter; Bernie Richter, Alvin Gross, Cecil Schuh and wife Betty Schuh, and Cynthia Wahl.

Chairman Ehrman called the meeting to order. The purpose of the special meeting was

to act on a flex benefit program with Total Administration Services Corp. (TASC) for County Employee individual health insurance premium reimbursements, discuss culvert issues, and review GPS motorgrader program quotes.

County Auditor, Shirley Murray, reviewed the Total Administration Services Corporation (TASC) to provide a flex benefit program for medicare eligible County Employees that the County would reimburse for individual supplement health insurance premiums.

Monty Bader, Insurance agent, reviewed the medicare plan that there is no deductible or co-pay and picks up 80% of medical cost. A Part F supplement health insurance plan is needed to pick up the remaining 20% of medical cost. A Part D supplement health insurance plan is needed for prescription coverage. Different companies cover for certain prescriptions. Bader recommended discussing with your pharmacist what prescription company would be best to go with for each individual's prescriptions.

It was moved by Commissioner Erdmann to approve the TASC agreement to provide insurance premium reimbursement benefits for medicare eligible employees effective November 1, 2012 seconded by Commissioner Ehrman. Upon roll call vote – Erdmann – yes, Ehrman – yes Motion carried.

The cement culvert on the south secondary road from Martin City will be dug up and replaced with a new culvert. Graveling will be done on some twp roads yet this fall as weather allows.

The auditor presented a GPS motorgrader tracking quote from Jason Pearson, RDO Equipment. The board instructed the auditor to invite Pearson to the October Commission meeting to discuss what data the GPS motorgrader tracking program will provide.
